

## TERMS OF SERVICE

### 1. Introduction

Welcome to **Rivered** (“**Company**”, “**we**”, “**our**”, “**us**”)! As you have just clicked our Terms of Service, please pause, grab a cup of coffee and carefully read the following pages. It will take you approximately 20 minutes.

These Terms of Service (“**Terms**”, “**Terms of Service**”) govern your use of our web pages located at <https://www.rivered.io> operated by Rivered.

#### **4. Subscriptions**

Some parts of Service are billed on a subscription basis ("**Subscription(s)**"). You will be billed in advance on a recurring and periodic basis ("**Billing Cycle**"). Billing cycles are set either on a monthly or annual basis, depending on the type of subscription plan you select when purchasing a Subscription.

At the end of each Billing Cycle, your Subscription will automatically renew under the exact same conditions unless you cancel it or Rivered cancels it. You may cancel your Subscription renewal either through your online account management page or by contacting Rivered customer support team.

A valid payment method, including credit card, is required to process the payment for your subscription. #### **5. Free Trial**

Your continued use of Service after Subscription fee change comes into effect constitutes your agreement to pay the modified Subscription fee amount.

### **9. Prohibited Uses**
